Legislative Update

Council Work

The Administration's working group along with Council Members are making progress to implement and adopt a **Wage & Compensation Scale** to ensure that all employees are paid according to scale based on position, ranking, job type, duties and description. This will ultimately allow the Pueblo to retain current employees, hire new employees to fill vacancies and offer a minimum to maximum range of pay for positions in order to continue providing the best of services to the community.

3 Branch Session

The Executive (Governor), Legislative (Tribal Council), and Judicial (Tribal Courts and Supreme Court) branches will convene sometime in August to share issues, bring awareness to trends and work toward addressing common concerns affecting the Pueblo.

Catering Opportunities

Council Committee Updates

The Enrollment Committee will be planning a community meeting in order to provide information and discuss changes to the draft **Enrollment Law** and welcome feedback from Tribal Members. An announcement will be forthcoming.

The Emergency Response Committee has begun reviewing and evaluating outdated **Emergency Management Plans** to better prepare the Pueblo and People for natural disasters and various emergency situations. The Committee is working to involve the Administration in the next steps of planning and drafting.

With half of the year remaining, The Tribal Council has reviewed its **Goals & Priorities for 2022** and Council Committees will be planning meetings to address many important issues and goals which benefit and affect the Pueblo, People and Tribal Administration.



Random Laws

The Legislative Office will place random laws in our newsletter to 1) remind the community of what laws currently exist in the Tribal Code and 2) to surface laws that may need to be revisited, amended, updated and etc.

Part 6.5.20 Grant Application and Authorization Act of 2018

6.5.20.030 Purpose

The purpose of this Act is to provide the Governor and Executive Branch Departments with standing authority for two years to apply for and obtain grant funds for the Pueblo without the need to seek legal authorization from the Council for each grant application on a case-by-case basis.

6.5.20.040 Findings

- (a)** The Pueblo receives significant funds through grants from governmental and private sources to operate the Pueblo's government and programs for the benefit of the People; and
 - (b)** The Council supports and encourages the Governor and Executive Branch Departments to apply for and obtain available grant funds for the benefit of the Pueblo; and
 - (c)** Section 5(a)(ii)(A) of the Governing Agreement permits the Council to make budget modifications *without limitation* at any time to obtain and expend new grants funds or to appropriate matching funds for new grants, which demonstrates the Pueblo's support for a streamlined and efficient application and expenditure process; and
 - (d)** The Council finds it in the best interest of the Pueblo to provide the Governor and Executive Branch with an efficient and streamlined process to authorize the Pueblo to apply for, receive, and expend grant funds. ([September 14, 2015, SI-R15-026.](#))

6.5.20.050 Grant Authorization

- (a)** The Governor and Executive Branch Departments are hereby authorized to apply for and receive grant funds from any governmental or private source for the benefit of the Pueblo through the end of the Fiscal Year 2024; provided that any matching funds that may be required to obtain a grant shall be separately appropriated in a budget or budget modification prior to the acceptance of such grant, and provided further, that no grant shall be accepted unless such grant includes funds for the Pueblo's indirect costs or the Council has specifically authorized the acceptance of the grant without indirect costs; and
 - (b)** The Governor is hereby authorized to prepare the necessary documents to apply for and obtain grant funds in a form and manner acceptable to the funding source, including the authorization to prepare and certify a Council Resolution that may be required by the funding source and such Resolution shall include the date and vote tallies of this Act and such Resolution shall not be required to be presented to Council for another approval; and
 - (c)** The Governor shall provide written notice to the Council of all grants applied for and/or obtained by the Pueblo on a quarterly basis.

NOTICE

NOTICE IS HEREBY GIVEN by the Pueblo de San Ildefonso Election Commission that, pursuant to the *Governing Agreement* adopted on December 21, 2011, there shall be a **GENERAL ELECTION** on the first day of December of each year. Pursuant to the Pueblo's Election Law, there shall be a **PRIMARY ELECTION** on the last Saturday of October each year.

As required by the Governing Agreement, the Pueblo of San Ildefonso is seeking Nomination of Candidates for five Council Representatives. The Election Law requires the Pueblo to take "nominations of persons seeking elective office" beginning September 1st and ending September 15th.

Each nominated candidate is required to submit to a Criminal Background check and the results shall be made available to any enrolled Member of the Pueblo, as required by the Agreement, Section 2 Election Commission, (d).

CANDIDATE NOMINATION PERIOD

DATE: September 1st through September 15th, 2022

PRIMARY ELECTION

DATE: Saturday, October 29, 2022

GENERAL ELECTION

DATE: Thursday, December 1, 2022

Open Seats: The following seats will be filled in the General Election

Nominations for Office

Any qualified person wishing to run for office must complete a Candidate Nomination and Criminal background form. Candidate Nomination and Criminal Background forms are available at the Governor's Office, Legislative Office or through any of the Election Commissioners (EC's). Completed forms may be returned to any of the Election Commissioners.

Please Note: As required by the Governing Agreement, a criminal background check will be conducted on all candidates for elective office, and the results of the background checks will be made available to any member of the Pueblo upon request.

DEADLINE TO FILE A CANDIDATE NOMINATION FORM IS:

Thursday, September 15, 2022 by 4:30 p.m.

SEPTEMBER 15TH, CANDIDATE NOMINATION FORMS WILL BE ACCEPTED AT THE SAN I LIBRARY FROM 8:00 AM TO 4:30 PM.

After the passage of the Candidate nomination deadline, the Election Commission will post a list of candidates and a list of eligible voters by **September 16, 2022.**

Qualifications

The Agreement sets the qualifications to run for open seats as follows:

Council Representative: Member of the Pueblo at least 25 years old (A person who "wins" a Council Representative seat must establish residency within the exterior boundaries of the Pueblo within thirty days).

Voting Age

Any Member of the Pueblo age eighteen (18) or older by October 30, 2022, shall be entitled to vote in the Primary and General Election. Any Member of the Pueblo age 18 or older, as of October 30, 2022, will be permitted to vote in-person at the polling place during voting hours. The Election Commission will post a preliminary list of eligible voters at the designated locations of the Governor's Office, Tewa Center, public bulletin boards, and other public locations, along with notice to the Governor and the Lieutenant Governor, at the earliest possible time after the end of the challenge period or the completion of the challenge appeal process. Any Member of the Pueblo may challenge a name on the voters list and/or may challenge the omission of a name from the voters list by submitting a written challenge to the Election Commission by September 30th, 2022 by 4:30 pm. The Election Commission will rule on all challenges and will post a final list of eligible voters by October 15th, 2022.

Candidates for Council Representatives shall be enrolled Member of the Pueblo, and at least twenty-five years old on the deadline date for filing candidacy. Once a candidate is sworn in as a Representative, the Representative shall have thirty days to establish residency within the exterior boundaries of the Pueblo as defined at the time of the adoption of this Agreement.

Certification of Candidate Qualifications

By signing below, I hereby certify that I meet the qualifications for elective office, and that upon election to office, I will follow the requirements for office including any requirement to establish my residency within the exterior boundaries of the Pueblo.

Under the Amended Election Law: Article III – Nominations; Section 1. Nominations, A Self – Nomination, 1. Any qualified member of the pueblo may submit his or her name in writing to the Election Commission as a candidate for elective office, along with a non-refundable fee of \$25.00.

Consent to a Criminal Background Check

By signing below, I hereby give my permission to the Pueblo de San Ildefonso Election Commission and its agents and representatives to conduct a criminal background check on me and to make the results of such background check available to any Member of the Pueblo upon request. I hereby authorize the custodians and their representatives of records and sources of information, including any Tribal Court records, to furnish the information to the Pueblo de San Ildefonso Election Commission and/or its agents and representatives with the information requested in the process of a background check. I understand that the background investigation will include criminal record history, whether or not such information would otherwise be protected from disclosure by any constitutional, statutory or common law privilege.

I hereby agree to accept all risks of adverse public notice that may result from use of information obtained in connection with this criminal background investigation. I hereby agree to indemnify and hold harmless any person to whom this is lawfully presented and his agent and employees from and against all claims, damages, losses, and expenses, including reasonable attorney fees, arising out or by reason of complying with this request.

By signing below, I hereby acknowledge that I will be required to complete and sign an electronic email verification sent to me by **FIRST CHOICE BACKGROUND** within **2 days** of receiving **FIRST CHOICE'S** email to authorize the release of my investigative information. I understand that my nomination as a candidate for an elective office will only be considered upon the completion of this **FIRST CHOICE EMAIL VERIFICATION**.

YOU MUST COMPLETE A SEPARATE CONSENT FORM AUTHORIZING A CRIMINAL BACKGROUND CHECK.

International Day of the World's Indigenous People is recognized every year in August.

A few years ago, Indigenous groups all over the world were granted August 9 as a day to raise awareness, promote, and protect the rights of Indigenous People around the world.

For clarification, the terms to distinguish groups who lived in the United States before European contact were called "Native American, American Indian, Alaska Native, or Native People." According to UCLA, the definition that distinguishes "Indigenous People" are those groups who share a national identity. These names have been used interchangeably, so this newsletter will do the same. No matter the name of these groups, we have similar themes that resonate with our lives.

Contributions

A few of the notable contributions made by Native People have been identified by the Natural Resources Conservation Services.

One of these influences was recognized to show a system of hand signals, hand signals were created to communicate to trappers and traders. Today, Native people have been given credit and this form of communication allows communication to the deaf or those unable to speak.

Another important role instilled in our people was called the Indian Value System. This system emphasized important responsibilities from respecting Mother Earth and Fellow Man to acknowledging the Great Spirits to name a few.

One of the influential roles highlights traditional music and intricate artwork and the inherited talent of the local groups.

Some research identifies how art-based practices could be beneficial to Indigenous groups, for starters it may allow for participants to be involved, it helps to build relationships, while building on indigenous knowledge and developing and strengthening skills. Many communities hold traditional artwork with little knowledge of the beneficial aspect to promote mental, social, emotional, and physical health.

This month many indigenous groups will come together and participate in events all around the world and a few will take place here in New Mexico.

Let's celebrate together as we share our gifts with others.

Career Training with I-BEST



The Integrated Basic Education and Skills Training (I-BEST) Program at SFCC provides you with career pathways for automotive, early childhood education, or health care. You will learn job-related skills while you strengthen your reading, writing, and math abilities.

What's in it for you? In 1-3 semesters you can:

- Complete a college certificate
- Receive job placement support upon completion
- Improve your reading, writing, math, and English skills
- Get your High School Equivalency (if you need one)
- Earn credits towards an associate degree.

I-BEST will provide:

- A study plan designed for your busy schedule
- The opportunity to prepare for a career in a high-demand job area
- Individual attention and advising with career and academic planning
- Financial aid guidance and support
- Improved computer skills
- User-friendly adult education classes and tutoring
- Connection with a group of adult classmates in a safe and comfortable learning community.

I-BEST Certificate Programs:

Automotive Maintenance and Light Repair

This two-semester program prepares students to enter the automotive repair profession as an entry-level technician, performing basic maintenance on vehicles such as oil changes, tire rotation, and the multi-point vehicle inspection. Students will also have access to computer training modules to support classroom work. This program includes: Introduction to Automotive Technology, Automotive Electrical and Electronic Systems I, Automotive Steering and Suspension Systems, Automotive Brake Systems, and Automotive Heating and Air Conditioning.

Community Health Worker

This one-semester program prepares students to enter the healthcare profession as an entry-level Community Health Worker (also known as Community Health Representatives, Patient Navigators or Patient Service Representatives), who serve as patient advocates and educators in clinics, hospitals and managed care organizations. Program completion enables students to qualify for the New Mexico state certification for Community Health Worker.

Nursing Assistant

This one-semester program prepares you to enter the nursing profession as an entry-level nursing assistant, meeting all federal certification standards for a nursing assistant and being prepared to sit for the New Mexico Nurse Aide Registry exams. Class credits apply toward an Associate Degree in Medical Assisting should you wish to continue your studies.

Preparation for Medical Assisting

This three-semester program encompasses the competencies needed to become a professional medical assistant. Specific education includes performing administrative and clinical procedures in settings such as physician offices, clinics and ambulatory settings. This program of study is oriented to students who have an aptitude for organization and health care systems. Class credits apply toward an Associate Degree in Medical Assisting.

Phlebotomy

This one-semester program is designed to provide the necessary skills for gainful employment as a phlebotomist, working under the supervision of a clinical laboratory supervisor and responsible for the proper collection, processing and testing of blood specimens and various other medical samples. Upon successful completion, you will be eligible to apply for the national licensing through the American Society for Clinical Pathology. Class credits apply toward an Associate Degree in Medical Assisting should you wish to continue your studies.

Early Childhood Development

This three-semester certificate provides the course work necessary to apply for a New Mexico Child Development Certificate, a state-awarded certificate for early childhood teachers to meet the entry-level professional requirements for teachers who are already working in a classroom setting with preschool children. The New Mexico CDC is designed to assist Head Start and Early Head Start programs meet the interim staff qualification requirements. All certificate course credits apply toward an Associate Degree in Early Childhood Education should you wish to continue your studies.

I-BEST Student Registration

We are currently accepting applications for Certified Nursing Assistant, Community Health Worker Automotive Maintenance and Light Repair, and Early Childhood Development the Fall 2022 Semester, which begins on August 22nd, 2022.

Orientation and Registration for Fall 2022 classes

There will be a required orientation scheduled in spring AND again in summer to prepare for the fall semester. **Students are required to attend one of these orientations.**

New students and current HSE/GED or ESL students are required to attend the program orientation before enrolling in classes. HSE/GED students will attend a two-day orientation program. New students will attend a three-day orientation which includes required testing in reading, math and language. Morning and evening orientation options are available. Morning orientation runs from 9:00 am to 11:00 am. Evening orientation runs from 5:30 pm to 7:30 pm. During orientation, you will learn more about the program, financial aid opportunities, and steps to enroll into classes.
