## Los Alamos County Call for Art

#### The Art in Public Places Board (APPB)

is soliciting for a  
fun and enjoyable  
art creation to  
transform a 500+  
square foot,  
concrete wall that  
faces North at the  
entrance to the  
Los Alamos Golf  
Course.

This project aims to  
beautify the space,  
foster community  
engagement, and  
celebrate creativity.

#### Entry Package (Include all items listed below)

1. Begin with your name, address, phone number, and email address. Follow with an introductory paragraph- a general descriptive narrative of the artwork being proposed.
2. Provide a detailed description of the proposed piece, including an explanation of why you think this medium, and image(s) are appropriate for the concrete wall at the Golf Course.
3. Each entry package must be clearly labeled with the artist's name, your name (if not the artist), title of the artwork, size (height, width, and depth), approximate weight, and description of materials used. Please provide as much information as possible to give the APP Board a complete explanation of the recommended artwork. Initial evaluation of the proposed project will be solely based on the information you submit in the entry packet. Semi-finalists may be given an opportunity to give an oral presentation to the APP Board.
4. Color photograph or rendering of the proposed artwork – not to exceed 11" x 17". Please include at least one **digital** image or photo of at least 300 dpi showing the work.
5. Include the artist's resume and photos of their work, work in a similar style, and/or similar projects in other communities.
6. Description and specifications for installation, including technical requirements for attaching to cement wall (if necessary).
7. Explanation of anticipated timeframe of project- from start to completion.
8. Description and schedule of recommended routine maintenance. Please address any possible public safety concerns.
9. Proposed purchase price (if known) or an estimated price range.

If your e-mail is returned as "undeliverable," please try re-sending your proposal components in multiple e-mails. The Los Alamos County Art in Public Places Board serves in an advisory capacity and makes recommendations to the County Council, who has the authority to accept or reject the board's recommendations.

## Entry Submittal Procedure

Entry packets may be mailed but must be **received no later than 5:00 p.m. on May 17, 2024.**

### Materials and Installation

All proposed artwork should have an expected life of at least 20 years considering Los Alamos County weather in all seasons. Please include installation description and specifications.

### Guarantee of Workmanship

Please be aware that for a period of one year from the date of acceptance of the artwork by the County, the artist will be expected to warrant and guarantee all workmanship and materials used in the work.

### Maintenance Schedule

Ongoing maintenance will be provided by the County. Please include a description and schedule of recommended routine maintenance if possible.

### Purchase Agreement

The selected artist will enter a formal purchase agreement with the County.

### Insurance

Please be aware that the artist shall obtain and maintain insurance of the types set out below throughout the term of the Purchase Agreement with an insurer acceptable to the County. Amounts and other details will be provided in the actual Purchase Agreement.

- Commercial General Liability Insurance
- Workers' Compensation
- Automobile Liability Insurance for Artist and its Employees

### Criteria to be used by the APPB in the Evaluation Process:

- Quality of the workmanship
- Reputation and/or recognition of the artist or artists
- Appropriateness of the art for the proposed location
- Maintenance requirements for the art
- Security factors (theft, vandalism, etc.) and public safety
- Price/Additional costs

### Entry Packet

- ✓ Please submit your Entry Package with the items listed above, including all images, and supporting material to the address listed below.
- ✓ Submit a separate packet for each proposed piece or recommendation. If mailed, please include a postage-paid return envelope.
- ✓ All entry materials should be typed or printed clearly.
