OFFICIAL NOTICE FROM THE GOVERNORS OFFICE



Please be advised the following guidelines for Tribal member household assistance are in place and must be followed.

Sewage Services

The Pueblo will be responsible for maintenance of the community sewage system to the property line to the house. INTERIOR HOUSE PLUMBING IS THE SOLE RESPONSIBILITY OF THE TRIBAL MEMBER. Exceptions to this are:

- 1) during funerals;
- 2) public housing currently under maintenance by the San Ildefonso Housing Authority;
- 3) low income households-income verification of all household members will be required and partial payment will be assessed on a sliding scale; and
- 4) households with family members who are handicapped or disabled-income verification of all household members will be required and partial payment will be assessed on a sliding scale.

Water Services

The Pueblo will be responsible for maintenance of the community water system to the property line to the house. INTERIOR HOUSE PLUMBING IS THE SOLE RESPONSIBILITY OF THE TRIBAL MEMBER. Exceptions to this are:

- 1) during funerals;
- 2) public housing currently under maintenance by the San Ildefonso Housing Authority;
- 3) low income households-income verification of all household members will be required and partial payment will be assessed on a sliding scale; and
- 4) households with family members who are handicapped or disabled-income verification of all household members will be required and partial payment will be assessed on a sliding scale.



OFFICIAL NOTICE FROM THE GOVERNORS OFFICE



All Tribal member households will be held liable for digging up lines that are clogged due to toys, boards, rocks, wipes, or anything clogging up the lines that should not be flushed down the toilet or sink. Tribal member households are responsible for keeping their yard clear of trees and bushes around the sewer system.

Facilities and Housing Department staff will only respond during the hours of 6am to 7pm.

Burial assistance

The Pueblo de San Ildefonso provides the following guidance to the community relating to burial assistance for all Tribal members.

In the event a Tribal member passes, the next of kin should call Governor Moquino as a courtesy. The family will be asked if assistance from a funeral home will be required. If so, Rivera's Funeral home in Espanola will be called and put on notice. The Pueblo has a contract in place with Rivera's Funeral home. The types of services vary depending upon the Family's wishes. The Pueblo will pay no more than \$1,000 to Rivera's funeral home. Examples of services:

- Body transport from the Office of Medical Investigator in Albuquerque;
- Body transport to Rivera's funeral home;
- Cold storage until home is ready to receive the deceased loved one; and
- Transport body from funeral home to Family home.

Expenses incurred from any other funeral home other than Rivera's will be the responsibility of the deceased Tribal member's family. In addition to the above, the Pueblo provides a monetary donation to assist with family funeral activities. Please call the Governor's office if you have any questions.

PUEBLO DE SAN ILDEFONSO GENERAL ELECTION

DATE: SUNDAY, DECEMBER 1, 2024

TIME: 7:00 a.m. to 7:00 p.m.

POLLING PLACE: LEARNING CENTER/LIBRARY

VOTER REGISTRATION IS NOT REQUIRED. Any enrolled member of the Pueblo age eighteen (18) or older by December 1, 2024, is eligible to vote inperson at the polling place during voting hours. Absentee voting will be permitted in this year's Election for those that meet the eligibility criteria.

While the polls are open from 7:00 a.m. to 7:00 p.m., no persons except members of the Election Commission shall be allowed to remain within fifty (50) feet of the polling place. Campaigning is not allowed within fifty (50) feet of the polling place.

Voting Safety

While we encourage everyone to exercise your right to vote, it is everyone's responsibility to take the Pueblo's public health orders and safety precautions seriously in order to protect yourself and others in your family and community from contracting the COVID-19 virus.

Masks and gloves are optional while participating in the voting process but they are encouraged. If you are in line at 7:00 p.m., you will be allowed to vote.

Ballot Instructions

Eligible Voters will be allowed the following number of votes for the General Election:

- Up to five (5) Votes for Council Representatives
- If you mark **more** than the allowed number of votes for a position then that section of the ballot will be considered spoiled and your vote will not be counted. If you mark **less** than the number of Pueblo de San Ildefonso Election Commissioners or Council Representatives of votes you are allowed for a position, only those votes that was marked will be counted, and that section will be valid.

NO WRITE-IN CANDIDATES WILL BE ALLOWED. If you write-in a candidate for a position then that section of the ballot will be considered spoiled and your vote will not be counted.

Background Check Reports

As required by the Governing Agreement, a criminal background check has been conducted on all candidates for elective office. OVERVIEW

1. Summary of Responsibilities

Under restructured Articles of Organization, the **Pueblo de San Ildefonso Council** is seeking a Member's Representative to serve in a professional capacity to provide leadership experience stemming from business, government, private or nonprofit sector work. Key in a Member's Representative is also a commitment to, and understanding of, the needs of the Pueblo community, Pueblo sovereignty and laws of the Pueblo.

The Member's Representative provides general oversight and monitoring of SIS LLC on behalf of the Pueblo de San Ildefonso, who is the sole Member of the LLC. The Member's Representative shall act in accordance with the authority and responsibilities set forth in the SIS Articles of Organization. The Member's Representative shall monitor the LLC as an asset of the Pueblo and shall act in the best interests of the Pueblo in fulfilling responsibilities. The Member's Representative does not exercise day-to-day management of, or control over, SIS or its business activities. The Member's Representative shall serve as the primary point of contact between the LLC and the Member and shall facilitate communications between the two. The Members' Representative shall receive compensation at the sole discretion of the Tribal Council in accordance with tribal law.

A detailed Position Description is available. The Position Description identifies the Job Summary; Appointment, Supervision and Removal; Essential Functions; and Minimum Qualifications.

2. Nomination Timeline and Process

The Nomination period for this 3-year term position beginning January 1, 2025 - December 31, 2027 opens on October 07, 2024 and closes on November 06, 2024 at 12:00 p.m. Nominees must provide a Letter of Interest and a Resume.

JOB SUMMARY

The Member's Representative provides general oversight and monitoring of San Ildefonso Services, LLC (SIS) on behalf of the Pueblo de San Ildefonso, who is the sole Member of the LLC. The Member's Representative shall act in accordance with the authority and responsibilities set forth in the SIS Articles of Organization. The Member's Representative shall monitor the LLC as an asset of the Pueblo and shall act in the best interests of the Pueblo in fulfilling his/her responsibilities. The Member's Representative does not exercise day-to-day management of or control over SIS or its business activities.

The Member's Representative shall serve as the primary point of contact between the LLC and the Member and shall facilitate communications between the two.

The Member's Representative shall receive compensation at the sole discretion of the Tribal Council in accordance with tribal law.

APPOINTMENT, SUPERVISION AND REMOVAL

The Member's Representative is appointed pursuant to the process set forth in the SIS Articles of Organization. The Member's Representative is subject to the supervision of the Tribal Council and Governor. The Member's Representative is subject to removal by the Tribal Council or the Governor pursuant to the process set forth in the SIS Articles of Organization.

ESSENTIAL FUNCTIONS

The Member's Representative's oversight and monitoring duties include, but are not limited to, providing assistance with SIS's planning, policy development and proposed legislative initiatives, and overseeing SIS's budgets, business plans, feasibility studies, and marketing studies.

A meeting of the Member's Representatives will be held annually, on the second Tuesday in June, or as otherwise scheduled by the Member's Representatives, for the purpose of electing the Manager of SIS; approving SIS's annual business plan and budget; and transacting any business that may come before the Member's Representatives at such annual meeting.

The Member's Representatives will meet with the SIS Manager no less frequently than on a quarterly basis to receive reports on, including but not limited to, SIS's financial and operating condition. Additionally, on an annual basis, the Member's Representative will receive reports from SIS Manager concerning the preceding year's financial statement and the upcoming year's financial forecast. The Member's Representative will promptly submit all such reports to the Tribal Council and Governor.



MINIMUM QUALIFICATIONS

Each person appointed as a Member's Representative shall possess a level of professional experience and expertise necessary to carry out the requisite duties of a Member's Representative and contribute to the ability of SIS to achieve its purpose.

A Member's Representative shall possess the following qualifications:

- 1. Extensive professional and leadership experience in business, government, or the nonprofit sector;
- A commitment to and understanding of the needs of the Pueblo community, Pueblo sovereignty, and the laws of the Pueblo;
- 3. Integrity, credibility, and a passion for the Pueblo's economic development activities;
- 4. Demonstrated ability to oversee a business for maximum profitability and performance, including fiscal goals and priorities, and operational procedures and guidelines;
- 5. A High School Diploma is required;
- A Bachelor's Degree in business administration, marketing, retail management, finance, or a related degree is preferred;
- Five plus years of experience in business, finance, government, and/or related management experience is preferred;
- 8. A combination of education and experience may be considered in meeting the requirements of numbers 6 and 7 above:
- Must pass a background check and successfully complete an alcohol and drug test prior to appointment; and remain subject random drug testing throughout term;
- Must have the ability to obtain special clearances and background investigations (per project requirement basis);
- 11. No person who has been convicted of a felony within the last five (5) years shall be appointed as a Member's Representative. A felony is a crime punishable by at least one (1) year in jail, regardless of whether the person actually served a full year in jail; and
- 12. No person who has ever been convicted of a crime involving theft or conversion of money or property shall be appointed as a Member's Representative.


The Transfer station has specific areas for waste to be disposed. We ask all Tribal/community members to please dispose your waste in the designated areas and bins. If you are

DECP News

National Tribal and Indigenous Climate Conference Report

From stories of melting permafrost and dwindling salmon runs to stream restoration in the Southwest, the National Tribal and Indigenous Climate Conference provided insight into the ways different tribes all over the US are adapting to climate change. I was



lucky enough to attend the conference at the beginning of September in Anchorage, Alaska on behalf of San I. I, along with Claire Lay of Abt Global, presented on the work DECP is doing restoring four natural springs to a state that is more reflective of historic conditions and more capable of handling drought and climate change in the future.

The presentation was part of a National Integrated Drought Information System (NIDIS) grant that DECP has been working on for a bit over a year. The work so far has involved removal of invasive species, like Salt Cedar and Russian Olive, as well as creation of exclusionary fencing to keep out destructive feral cattle. There is still another year left on the grant and we look forward to completing more of the work and continuing past this specific funding.

As mentioned, the conference brought together hundreds of tribes, state and federal agencies, and private organizations to discuss the ways in which tribal communities are affected by climate change and the ways they are responding to it. I learned about communities who were watching as the ground literally slipped away beneath them as the permafrost melted, leaving them no other choice than to move their entire community inland; and about increasingly erratic weather patterns and warming temperatures that are changing the behavior of species many communities rely on.

I learned also about the inspiring ways people were dealing with climate change and proactively confronting these issues. Many interesting and novel ways of restoring landscapes and preparing for climate change were presented. From increasing use of prescribed fire to restoration of water bodies all the way to community resilience efforts, like modernization of homes, tribes are on the front lines of climate change and are meeting the challenge. This conference was an excellent learning opportunity and made me excited to be a part of this kind of work. I was glad to represent DECP and present on the work we're doing.

The mission of DECP is to preserve and protect the natural environment and the cultural resources of the Pueblo de San Ildefonso, to assess risks to human health and welfare, both quantitatively and qualitatively, and protect the health and wel-

Pueblo de San Ildefonso Climate Action Plan

Situated in Northern New Mexico, east of the Los Alamos National Lab (LANL) and north of Santa Fe is the Pueblo de San Ildefonso. The region is home to vast pinyon-juniper forests, ponderosa pine forests, shrublands and grasslands. Although breathtaking, this diverse ecosystem is vulnerable to the impacts of climate change, natural disasters, and species encroachment. New Mexico figure experiences devastating wildfires annually, often fed by windstorms,

hotter, drier conditions and sometimes caused by more intense thunderstorms. While periods of drought can make wildfire conditions more likely and hazardous, less frequent but more intense rainstorms cause flooding and changes to snowmelt and streamflow patterns.

In the past, magpies - black and white birds in the Corvidae family - lived on the Pueblo year-round. Increasingly, Pueblo de San Ildefonso community members told the Pueblo de San Ildefonso Department of Environmental and Cultural Preservation (DECP) that they were not only seeing magpies for shorter lengths of time each year, but that other plant and animal species were harder to find, if they hadn't already disappeared from the region entirely. Climate change has brought apparent weather changes to the region, but species loss was an obvious indicator that the Pueblo de San Ildefonso Community needed to develop a Climate Action Plan (CAP).

CAP Development

The Pueblo de San Ildefonso CAP was born from community concerns about changes to the environment and local species, so it was only natural to begin the CAP planning process with further community involvement. The Pueblo held targeted community workshops where they hosted discussions about community life, perceptions on climate change, and observed climate impacts and vulnerabilities within the community. After identifying and defining this community vision to address climate impacts on the Pueblo, the DECP worked with an external contractor to begin writing and developing a CAP. They evaluated the likelihood of various climate change impacts affecting the Pueblo and the consequences these impacts might have. After determining which climate impacts the Pueblo de San Ildefonso is most vulnerable to, the DECP and their contractor determined the best strategies for reducing the risk of these climate impacts. The CAP describes steps for implementing the various climate mitigation and adaptation strategies listed and recognizes that this will be an ongoing process following publication.

Traditional Pottery

Given the prioritization of community input, the CAP is specific to the region and emphasizes cultural resources that will be impacted by climate change, or that can be revitalized and used to combat climate impacts. Community members addressed their concerns around traditional activities, such as traditional pottery making, that are being impacted by climate impacts. Clay deposits are drying up because of warmer temperatures

and higher winds, and sometimes no clay can be found in areas that historically had large clay deposits. Plant species used for decorating traditional pottery, such as yucca, also aren't found in all the same places they once were. The DECP is exploring the creation of a tree farm or nursery for narrow leaf yucca, creating availability for local potters. While the Pueblo is trying to protect remaining environments where materials for traditional

pottery can be found, they're having bigger conversations around what does and does not constitute traditional pottery. As climate impacts continue in the region, some are considering that one day clays for traditional pottery may only be found in stores, fundamentally changing the nature of the pots. A consensus hasn't been reached, and community members may always have differing opinions on the matter. Cultural resources and traditions are having to be adapted and reconsidered with the change in climate.

Community Gardens and Traditional Crops


Community gardens for traditional crops have already been established in the Pueblo, but the CAP emphasizes how important it is to make these gardens more accessible to all community members, regardless of age. The Pueblo was heavily reliant on farming and livestock in the past, though many families now tend smaller gardens. To teach youth about the importance of gardening and traditional foods,



a local K-6 grade school assists with the Pueblo Community Gardens. This educational program also seeks to encourage students and their families to plant home gardens. Educators at the Community Garden incorporated the Tewa language throughout the garden, teaching youth the names for crops, weather, and other climate phenomena. The schoolchildren love to see their hard work produce crops like pumpkins, squash and corn, so much so that they entered some of their crops in the New Mexico State Fair and cherish the ribbons they won. They save seeds from their best, most climate-resilient crops to plant the next year, in hopes that

they can grow traditional crops in a drier, hotter climate.

Land Boundaries and A Unique Neighbor In 2000, the Cerro Grande fire, with flames 100 feet high, came through San Ildefonso lands. The fire started when a prescribed burn grew out of control due to wind gusts of up to 50 mph and drought conditions. In attempts to control the fire, emergency responders constructed a firebreak around the LANL, where the Pueblo de San Ildefonso shares a common boundary. Bulldozers ran over cultural sites, and the environment is still recovering from the firestorm. To prevent future damages to cultural and environmental resources, the Pueblo de San Ildefonso Tribal Rangers have started to accompany non-Tribal emergency responders, a strategy outlined in their CAP. Tribal Rangers open gates, show non-Tribal emergency responders access roads and other areas, and continue to follow them so long as they remain on Pueblo lands. The Pueblo de



San Ildefonso CAP emphasizes the need to build their capacity with their own emergency response teams to prevent unnecessary trespass.

Sharing land boundaries with LANL puts the San Ildefonso Pueblo in a unique predicament. Not only does this situation create legal challenges regarding land boundaries, it also has created cultural and natural resource losses that would not have been otherwise present. As climate change impacts across northern New Mexico continue in their severity, the San Ildefonso Pueblo is examining the exacerbation of environmental impacts given their proximity to LANL. For example, as storms become more intense, runoff contamination from LANL is more apparent. San Ildefonso Pueblo has already traced chemical contaminants from the Rio Grande and the Cochiti Pueblo Reservoir back to LANL. Wildfires increase the risk of flooding, therefore also increasing the risk of exposure to these chemical contaminants through runoff.

While the legacy of LANL is controversial, the San Ildefonso Pueblo is working together with the Laboratory to develop solar projects on the Pueblo boundaries and to the north of the Pueblo. These solar projects not only develop clean energy sources across the region and for the Pueblo but have rain capture mechanisms that water vegetation underneath the shade of the solar panels. LANL is exploring this new agricultural method with some groundcover vegetation, but the Pueblo de San Ildefonso wants to experiment with traditional crops under these solar panels. Considering new, climate focused projects such as solar panels, green economic development on the Pueblo and energy efficient infrastructure is going to drive the future versions of the Pueblo de San Ildefonso CAP.

Future Developments of the CAP

The Pueblo de San Ildefonso DECP wants to keep the Pueblo informed and educated about the impacts of climate change on their homelands. Fortunately, the community has been highly receptive to participating in the development and implementation of the CAP, something the DECP has been incredibly grateful for. The existing CAP prioritized listening to the community's concerns and incorporating their knowledge first, and the DECP is going to continue to prioritize that in the future.

The Pueblo de San Ildefonso DECP is always looking for feedback on their CAP. They emphasize the importance of sharing their CAP and the process of developing it so that others can benefit from the lessons they learned. While they have developed a CAP and are finding ways to implement it in every department and program at the Pueblo, they remain humble and open to hearing what they can do better. 
POJOAQUE BASIN REGIONAL WATER SYSTEM (PBRWS) NEW MEXICO STATE ROAD 502 CONSTRUCTION UPDATE


On October 7, 2024, the Bureau of Reclamation's contractor CDM Smith began performing potholing activities along New Mexico State Road 502 westbound, within the exterior boundaries of the Pueblo of San Ildefonso, in the area shown in Figure 1 below.

Potholing work consists of locating existing utilities through limited excavation and boring activities. In the next couple of weeks, potholing activities will not require lane closures, but speed limit through the work zone is reduced to 45MPH. Potholing activities are estimated to take between 3 to 4 weeks depending on the local conditions. After completion of potholing activities, pipeline work will commence, and will take approximately 9 months. Pipeline work will be announced through message boards two weeks prior to commencing.

Traffic will be limited to one (1) lane during pipeline work and the posted speed limit will be reduced to 45 mph through the work zone.

All potholing and pipeline activities adhere to NMDOT safety and traffic regulations.

Physical Science Technicians

Physical science technicians perform physical science tasks in hydrology, atmospheric science, and geology, and other physical sciences. They assist with natural resource projects related to the physical sciences, collect and organize field data, monitor and evaluate field conditions, and prepare reports.

Maintenance Workers (Historic Preservation)

Historic preservation maintenance workers perform simple and routine work involved in the maintenance and repair of grounds, exterior structures, buildings and related utilities. Such work requires the use of a variety of trade practices associated with occupations such as masonry, carpentry, plumbing, roofing, painting, and other work such as associated documentation, reporting, and monitoring performed as part of a multi-disciplinary preservation program in the conservation of historic and prehistoric sites and structures.

Maintenance Workers (Trails)

Trail workers work primarily on backcountry and front country trails, assisting journeyman level tradesmen in all areas of trails maintenance.

Masonry Workers

Masonry workers perform various masonry tasks in the stabilization and rehabilitation of structures.

Preservationists

Preservationists perform work on preservation projects for a variety of historic structures. This entails the full gamut of types, and includes some new construction, major restoration or rehabilitation, complete stabilization, significant alteration, etc.

San Ildefonso Services Update Open house and solar meeting November 14th at the Tewa Center

SIS has won a \$200K grant with Grid Alternatives for the construction of a 50 KW covered parking structure. The project will use \$144K of matching funds from DOE Grid Resiliency Grant, and \$22K of State of New Mexico Matching Grant funds program through Indian Affairs Department.

Design of the project will start in the coming weeks with Grid Alternatives visiting the Pueblo to gather site information and to hold an open house. (See the attached flyer). Ordering of materials will take place in the coming months with construction planned for early spring 2025.

As a part of the project, Grid Alternatives will be working with the Pueblo for workforce development. This will be the opportunity to learn the solar system installation process and participate in the construction of the project.

Additionally, SIS has worked through an contractor selection process to select AES to work with SIS to evaluate the potential for a larger scale solar project to develop and provide renewable energy back to the Pueblo as well as producing energy to sell to Los Alamos and/or back into the grid. This project is in the very preliminary stages and AES project managers will be in attendance a the open house.

Grant awarded for 2024-2025

Solar Carport Preliminary Design

GRID will offer development, engineering, and construction services. The solar PV system will generate 90 MWh yearly, offsetting all electric utility costs for the Administration Building, saving \$12,000 annually. The carport will offer shaded parking and the chance to possibly include electric vehicle chargers and battery energy storage systems.
