# 10 HEALTHY HABITS FOR YOUR BRAIN

TAKE CHARGE OF YOUR BRAIN HEALTH. THESE HEALTHY HABITS CAN LOWER THE RISK OF DEVELOPING COGNITIVE DECLINE AND POSSIBLY DEMENTIA. THIS IS TRUE EVEN FOR PEOPLE WITH A HISTORY OF DEMENTIA IN THEIR FAMILIES.

Follow as many of these tips as possible to achieve the most benefits for your brain and body. It's never too late or too early. **Start now!** 



# Protect your

Help prevent an injury to your head. Wear a helmet for activities like biking, and wear a seatbelt. Protect yourself while playing sports. Do what you can to prevent falls, especially for older adults.





Quitting smoking can lower the risk of cognitive decline back to levels similar to those who have not smoked. It's never too late to stop.



#### Get moving

Engage in regular exercise. This includes activities that raise your heart rate and increase blood flow to the brain and body. Find ways to build more movement into your day — walking, dancing, gardening — whatever works for you!

# Challenge your mind



Be curious. Put your brain to work and do something that is new or hard for you. Learn a new skill. Try something artistic. Challenging your mind may have short- and long-term benefits for your brain.



Control your blood pressure

Medications can help lower high blood pressure. And healthy habits like eating right and physical activity can help too. Work with a health care provider to control your blood pressure.

# Manage diabetes



Type 2 diabetes can be prevented or controlled by healthier eating, increasing physical activity and medication, if necessary.



#### Sleep well

Good quality sleep is important for brain health. Stay off screens before bed and make your sleep space as comfortable as possible. Do all you can to minimize disruptions. If you have any sleep-related problems, such as sleep apnea, talk to a health care provider.



#### Stav in school

Education reduces your risk of cognitive decline and dementia. Encourage youth to stay in school and pursue the highest level of training possible. Continue your own education by taking a class at a local library, college or online.

## Eat right



Eating healthier foods can help reduce your risk of cognitive decline. This includes more vegetables and leaner meats/proteins, along with foods that are less processed and lower in fat. Choose healthier meals and snacks that you enjoy and are available to you.



# Maintain a healthy weight

Talk to your health care provider about the weight that is healthy for you. Other healthy habits on this list — eating right, physical activity and sleep — can help with maintaining a healthy weight.

#### **Senior Advocate**

My name is Stuart Christian and I am the new Senior Advocate here at San I. My office is located at the back of the Senior Center Building and my office hours at the present time are from 8-5. My phone number is 505-455-4143 and my email is: senioradvocate@sanipueblo.org

One of my duties is to help seniors find resources, so I will be learning what resources are available for seniors and I will put those in future bulletins.

At present, for seniors (50+), the tribe has a reimbursement program for internet bills. Submit paid receipts to Rhonda Cata at the governor's office. Max per receipt is about \$49.

I tried lighting my furnace the other day and got down on the floor and it took me about 15 minutes to get back up (I've fallen and can't get up!). If you need help lighting your furnaces, call me and I will try to get someone at housing to come by and look at your situation and then they can determine if they can assist. Don't freeze!

Another of my duties is to advocate for you for such items as: understanding bills from phone or utility companies. Problems with Social Security, Medicare, Medicaid, insurance claims/bills and taxes.

And call me if you have problems with any agencies such as IHS, BIA, any other state or federal agency.

Need help deciding on which Medicare/Medicaid plan to sign up for? Or if approaching retirement, how to sign up for Medicare, or Medicaid? Call or come by and let's talk.

If you need help in reviewing your IRA or other retirement programs, or need to find out what funds you have to distribute per law, call or come by and we can discuss this.

Keeping this private is what I have to do, so your information or status will not be shared with anyone, not even my boss. This is a HIPA requirement for medical records and for financial items, just plain zipping my mouth. What happens in my office stays in my office!

At present I am not able to drive a tribal vehicle as I need to take a defensive driving course first, but we do have a senior driver just hired, so if you need to get somewhere (medical, or bill paying) let me know and I will try to get our senior driver to help you out.

A reminder that the senior center serves lunch from 11:30 to 12:30 M-F with breakfast served on the last Friday of the month (Oct 24 for October) starting at 10-11. No charge for seniors age 50+. If you are home bound, let me know and I can work with you to get the paper work done so that the senior center can deliver food to your home.

A reminder that if you have a smoke detector, you should replace your battery in the month of November. If you need help doing it, call me.

#### **Tunyo Pin Activities for November:**

Due to a lot of holiday activities, the seniors at the last Tunyo Pin meeting (held Oct 15) decided to only have a Cookie Fest on November 13. Bring freshly baked cookies (+12) for sharing with others and bring some more (6?) as the senior center driver will deliver some of the cookies to their regular home bound seniors the next day.

Next Tunyo Pin meeting will be Nov 19 at 10 am at the senior center.

Arts and craft session will be to make thanksgiving items. Nov 7, 1-3 at the senior center.

# **Hunting Information**

The Rifle Season for Deer-Buck will start
November 4, 2025 to December 31, 2025. The
Rifle Season for Elk-Bull, Cow will start
November 4, 2025 to January 31, 2026.

The latest Rifle Proclamation has been released, outlining the regulations and permitted hunting zones for the upcoming season. Hunters are reminded to review the proclamation carefully to ensure compliance with all rules. The Proclamation can be found on the San I website.

Purchasing of hunting licenses can be issued by the Tribal Rangers or Natural Resources Director. Each license is \$30.00. Accepted payment for the licenses is cash or credit card. Credit card is the preferred method.

For every hunting license purchased, a harvest report is REQUIRED.

A community hunting survey is now open.
Feedback will help improve future hunting seasons and regulations. Participation is encouraged and can be completed online.

Community members are encouraged to report any concerns regarding animal neglect or abuse to the Parks & Wildlife office.



# Pueblo de San Ildefonso Office of the Governor

### HUNTING PROCLAMATION September 2025

WHEREAS, the Governor, by and through the Governing Agreement is charged with the enforcement and administration of the laws of the Pueblo de San Ildefonso (hereinafter referred to as "Pueblo") including all laws related to hunting within the exterior boundaries of the Pueblo; and

WHEREAS, the Governor is authorized to establish, by proclamation, open and closed seasons for the killing or taking of all species of big game animals and types of hunts by Section 1.9 of the Pueblo de San Ildefonso Big Game Hunting Act, Pueblo de San Ildefonso Council Resolution No. SI-R12-043 (hereinafter referred to as "Big Game Hunting Act"); and

WHEREAS, the Governor is authorized to establish, by proclamation, bag limits covering all big game species and the numbers thereof which may be killed or taken by any one person during any one day or during any one open season by Section 1.11 of the Big Game Hunting Act; and

WHEREAS, the Governor recognizes that the fall and winter seasons are the traditional hunting seasons for big game;

THEREFORE IT BE PROCLAIMED that September 15, 2025 through September 30, 2025 shall be open season for Bow Hunting-Deer Buck. Any Pueblo Hunting License holder for Deer-Bow may hunt during this period in accordance with the provisions of the Big Game Hunting Act and all applicable laws and regulations. A fee of \$30.00 shall be charged for every Pueblo Hunting License for Deer Buck-Bow issued. Upon issuance of a valid Deer-Bow license, each member may take one legal Deer Buck, as defined in Section 1.12(a) of the Big Game Hunting Act, during open season for Deer-Bow.

THEREFORE IT BE PROCLAIMED that September 15, 2025 through September 30, 2025 shall be open season for Bow Hunting-Bull Elk. Any Pueblo Hunting License holder for Bull Elk-Bow may hunt during this period in accordance with the provisions of the Big Game Hunting Act and all applicable laws and regulations. A fee of \$30.00 shall be charged for every Pueblo Hunting License for Bull Elk-Bow issued. Upon issuance of a valid Bull Elk-Bow license, each member may take one legal Mature Bull Elk, as defined in Section 1.12(b) of the Big Game Hunting Act, during open season for Bull Elk-Bow.

THEREFORE IT BE PROCLAIMED that September 15, 2025 through September 30, 2025 shall be open season for Bow Hunting-Cow Elk. Any Pueblo Hunting License holder for Cow Elk-Bow may hunt during this period in accordance with the provisions of the Big Game Hunting Act and all applicable laws and regulations. A fee of \$30.00 shall be charged for every Pueblo Hunting License for Cow Elk-Bow issued. Upon issuance of a valid Cow Elk-Bow license, each member may take one legal Cow Elk, as defined in Section 1.12(c) of the Big Game Hunting Act, during open season for Cow Elk-Bow.

BE IT FURTHER PROCLAIMED that any Pueblo Hunting License holder may not possess more than one of each type of license stated above during the Bow Hunt season for Deer Buck, Bull Elk and Cow Elk. If a hunter purchases and successfully harvests a tag for the Bow Season, the hunter is not eligible to purchase a license for the Rifle Season. Any unofficial use of any drone is not permitted or authorized under any circumstance within Pueblo boundaries.

BE IT FURTHER PROCLAIMED that Parks & Wildlife Tribal Rangers or the Natural Resources Director should be notified immediately of any kill. Harvest reports are required per license issued to hunter. Any hunter any the age of 17 years old or younger, is required to obtain a Youth Hunter Safety Training Certification. The hunter is required to provide proof of the certification at purchase.

BE IT FURTHER PROCLAIMED that in accordance with Section 1.8(a) of the Big Game Hunting Act, Natural Resources Director, Kate Bohannan, has designated open hunt areas on the attached map.

NOW THEREFORE I PROCLAIM IT ON THIS 2005 DAY OF Supt. 2025.

TO: Pueblo de San Ildefonso Community

FROM: Tribal Rangers & Natural Resources Department

SUBJECT: Partial Lift of Fire Ban – Controlled Burning Allowed on Limited Days Only

Now that fall is upon us and vegetation is drying out, we understand community members may wish to clean around their homes and burn small piles of natural debris. At this time, the fire ban is partially lifted — however, fire restrictions are still in effect.

Authorized Burning Days & Hours Only:

- Wednesdays, Thursdays, and Sundays
  - -8:00 A.M. -4:00 P.M. ONLY
- No burning outside of these days and hours will be permitted.

Important Requirements (Restrictions Still in Place):

- Burning is for natural debris only (no trash, plastics, lumber, or hazardous materials).
  - You must contact Tribal Rangers BEFORE ANY BURN begins.
    - A water source and shovel must be present at all times.
- No burning during high winds or Red Flag conditions Rangers may shut down burning immediately.
  - Absolutely NO campfires, recreational fires, or fireworks.

# Effective November 1<sup>st</sup> 2025!!!

Please be advised that the fee schedule has been updated for the Tribal Courts.

Keep in mind that the Court does charge:

- FILING FEES when papers are filed with the court (with the exception of Restraining Orders and Order of Protection)
- COURT COSTS when Court hearings are needed and/or scheduled
- OTHER FEES and COURT COSTS

Costs and fees are subject to change depending on each case and situation.

There are packets available at the Tribal Courts to fill out to request for court costs and fees to be waived, which will be determined by the judge.

As always, feel free to reach out to the Tribal Courts with any questions in regards to fees and costs.





## PUEBLO DE SAN ILDEFONSO TRIBAL COURT

## Section 3 – Membership Qualifications.

- a. Board members may be tribal members or non-tribal members.
- b. No person may be prohibited from serving as a member of the Board because that person is also a tenant or Homebuyer of Housing. There is an exception to this rule. Anyone who is delinquent on housing payments due to the authority is ineligible to serve of the Board.
- c. A Board member may participate in all meetings concerning matters that affect all of the tenants or Homebuyers even though those matters may indirectly affect the Board member as well; however, no Board member, in their capacity as a member of the Board, may participate in or be present at any Board meeting concerning any matter involving the Board member's individual rights, obligations, or status as a tenant or Homebuyer, except that the Board member may participate in or be present at such meeting only in their capacity as a tenant or Homebuyer.
- d. Board members must be at least 18 years of age.
- e. Board members may not be convicted felons.

#### PREVENTIVE TIPS FOR YOUR HOME DURING A SEASONAL CHANGE LIKE FALL AND WINTER:

As cold starts to settle in and it's time to turn off Air Conditioners (AC). It is important to unplug any window units and remove from window to close and seal window, if you choose not to remove window AC make sure, it is still unplugged and the area around the AC and window are sealed to prevent cold and air entering the unit. Swamp coolers need to have water supply shut off and removed from the home. Drain any water in the unit, unplug any electrical in the swamp cooler to prevent it being turned on. Install damper and cover unit with a tarp or cover and strap firmly to prevent cover coming off.

Make sure all outside water spigots or bibs are covered with Styrofoam covers and disconnect any hoses attached to the spigots during wintertime. This will prevent water from draining from hoses from freezing and entering the spigot causing bursting water lines within the walls.





Inspect all furnaces for dirt or lint. Vacuum or dust and remove filters to inspect for replacement. Filters in furnaces do have a directional arrow located on the side of the filter to show placement according to airflow. It is important that a filter is placed in the proper direction. Most modern furnaces do not have a pilot to turn on so when turning on thermostat furnace should ignite. If not a plumber or someone with knowledge with furnaces will have to be called. It is a smart idea to make sure vents are open and cleaned. In some circumstances duct cleaning might be needed.





Water heaters should be kept clean through vacuuming or simply wiping any accumulated dirt and dust. Do not store any items where Furnaces or water heaters are kept. This would prevent fires and allow those units to properly vent.

When fireplaces or wood stoves are used during wintertime, make sure they are properly cleaned of any ash, and any pipe vents are cleaned properly with a vent brush. Vents should be free of any accumulating ash or soot buildup; all these can prevent fires. Wood should be stored away from the house to prevent fires. Do not use gasoline or high combustibles to light a fire. Always have a fire extinguisher in an area that is accessible in case of fires and make sure that the extinguisher is full and in working order.
