### 2021 Council Priorities

Council's top priorities for this year are as follows: Creation of a **Tewa Language Dept./Program**, update/complete the **Personnel Policy Manual**, approve an updated **Organizational Chart**, **Emergency Management/Emergency Response** (COVID-19), update the 1999 **Enrollment Law**, approve a **Wage & Compensation** scale and complete a **Master Plan** for the community. These are all a work in progress and prioritized with the community's best interest at mind.

### Herd Immunity & COVID-19

Herd Immunity happens when a large portion of a community becomes immune to a disease. Generally 94% of the population must be immune to interrupt the chain of transmission. ## CULTURAL RESEARCH PROPOSAL

The Pueblo's THPO and THPO Advisory Board are still in the process of initiating consultation with traditional leadership in the community on the proposal by Mr. Mark Agostini to conduct work on the ancestral sites of **Otowi** and **Perage**.

As consultation continues the THPO will keep the Tribal Council and the Governor informed about the results of the consultation.

In the near future, THPO will present to the Tribal Council the results of the consultation for their consideration regarding the proposal.

## PURPOSE OF RESEARCH PROPOSAL

To establish a collaborative research partnership with the Pueblo of San Ildefonso to investigate and build on aspects of their historical connections to the Pajarito Plateau and their earliest ancestral village in the Rio Grande valley called Perage. The sites of Otowi on the Pajarito Plateau and Perage

in the Rio Grande valley are both on the San Ildefonso reservation and are identified in San Ildefonso oral history as ancestral villages.

This project will test the hypothesis that Ancestral Pueblo population dynamics and community networks are reconstructable using

architecture and ceramic data, and investigates how the nature and organization of those practices and systems of belief contributed to the development of the early Tewa social landscape.

## New Mexico Commodity Supplemental Food Program (CSFP) for Seniors

**NM HSD partners with community organizations throughout the state to provide nutritious food to supplement the diet of Seniors who may be at risk for malnutrition.** Currently, there are 5 regional centers and 122 tailgate sites located throughout the state who distribute a monthly box of food to eligible persons 60 years and older.

### **How Do I Qualify for CSFP?**

- Adults 60 years of age and older
- Residency: must live within the service area at the time of application for services.
- Income Eligibility Requirement: up to 130% of the Federal poverty guidelines published annually by the Department of Health and Human Services

### **How Do I Apply for CSFP?**

Applications are available at the warehouses and distribution sites. To Apply for CSFP benefits the applicant or caretaker of the applicant must provide the following information on the application:

- Proof of age and identity: driver license or picture ID
- Self-Declaration of Income and Residency. No Proof is Needed.
- Households seeking food assistance are frequently eligible for other assistance programs that may provide much needed resources.
- These programs include The Emergency Food Assistance Program (TEFAP), and the Supplemental Nutrition Assistance Program (SNAP). Non-nutrition programs such as Medicaid, Medicare, Savings Program (MSP) and Low Income Home Energy Assistance Program

(LIHEAP) are also available for qualifying persons. Information is available through the Income Support Division county offices and on line at <https://www.yes.state.nm.us>.

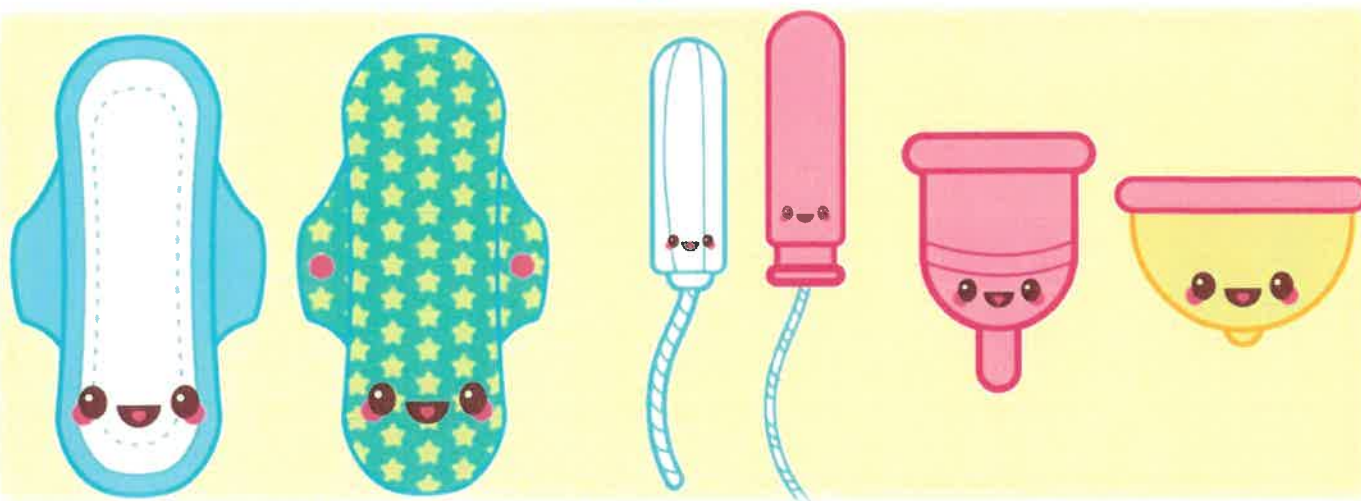

## Senior Community Service Employment Program **Fact Sheet**



### **ABOUT SCSEP**

At the National Indian Council on Aging (NICOA), we help Elders find work, develop new skills and talents, and build their financial security by taking advantage of the Senior

Community Service Employment Program (SCSEP). SCSEP is an on-the-job training and employment program designed to help those aged 55 and older update their jobs skills, build work experience and confidence, and continue to have economic security and wellbeing.

SCSEP is the only Federal program for Elders 55 or older and is administered by the U.S. Department of Labor under the authority of the Older Americans Act of 1965. NICOA is one of several national nonprofit agencies serving as a grantee to provide the program.

NICOA SCSEP provides services to anyone in our service areas eligible for the program. NICOA operates in designated counties in several states, feel free to contact NICOA to find the SCSEP service provider in your area.

Promoting Elders through job training and building real world skills have been key to NICOA SCSEP's success in Indian Country since 1989.

### **GOALS OF SCSEP**

SCSEP helps low-income job seekers, age 55 and over, gain skills necessary to re-enter the workforce. The program provides grant sponsored (subsidized) income and training to participants, while they serve their communities, which

improves their wellbeing and prepares them for regular (unsubsidized) employment. SCSEP delivers a "triple win" for our nation by promoting healthy aging and offering employment opportunities for low-income older Americans while providing a well trained workforce to local programs and agencies serving communities.

### **Benefits to Participants**

SCSEP enables thousands of low-income Elders each year to earn and learn while working in local programs serving their community. NICOA SCSEP provides skills, training, and job placement assistance to Elder job seekers that are looking to re-enter the workforce.

Once an Elder job seeker is accepted to the program they become a participant of SCSEP, and receive temporary and useful part-time training, job experience, resume building, and grant sponsored income to prepare them for finding employment in the community. NICOA prepares its participants to become more highly skilled applicants.

Participants have the opportunity to take part in a variety of service assignments, where they receive job training at a host agency site, which is a nonprofit or public agency. They also have the opportunity to participate in various trainings through NICOA partners and community organizations. Such training includes basic skills, ESL, computer literacy, and telephone systems.





## Benefits to Local Employers

SCSEP provides participants with the tools to transition to regular employment, which helps local employers address workforce shortages. Not only are SCSEP participants able to fill these shortages, but they have gone through the program to ensure that they are trained, qualified, and skilled mature workers.

NICOA and local workforce offices work closely with employers for job placement opportunities, to help employers find mature workers with qualifications that fit their work environment. NICOA staff also thoroughly assess each participant's skills, interests, and attitudes before referring the applicant to potential employers.

## WHY SCSEP IS IMPORTANT

While many people think of older adults as retirees, the truth is millions of Americans aged 55 and over work full or part-time jobs every day. According to the National Council on Aging (NCOA) the reasons they work are varied, but for many it's a matter of necessity to remain financially secure and independent. Others work to stay active and engaged in their communities. NCOA also states that as the population ages, older Americans will play an increasingly important role in our economy and America's leadership in the world marketplace. **By 2019, over 40% of Americans aged 55 and over will be employed, making up over 25% of the U.S. labor force.** (1) NICOA considers mature workers to be a

valuable resource and "markets" them through community contacts and employer partnerships.

## CHALLENGES IN INDIAN COUNTRY

According to the U.S. Department of Labor the national data that's available for American Indian and Alaska Natives paints a gloomy picture. More than one in four Native people live in poverty and their labor force participation rate—which measures the share of adults either working or looking for a job—is 61.1%, the lowest for all race and ethnicity groups. At 8.9%, the Native unemployment rate in 2016 was almost double the national rate of 4.9%. (2)

This is why NICOA SCSEP is so important, it serves as an American Indian set aside grant, which means the program focuses on addressing American Indian and Alaska Native Elder employment challenges and combats poverty. In the last 10 years NICOA SCSEP has served over 3,300 individuals, and in 2017 58% of participants were American Indian and Alaska Native Elders.

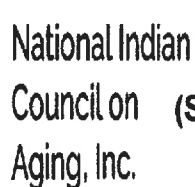

### **Where to Dispose of Oil and Oil Filters**

If you're a do-it-yourself mechanic, you probably already know how to maintain your car, including changing the oil. Put your used motor oil in a clean, leak-proof container like a plastic milk jug or an empty oil bottle. Make sure the cap is tightly sealed on the container, and store it in a cool, dry place away from heat, sunlight, kids, and pets. Many auto parts stores also sell drip pans that double as used oil receptacles. Under no circumstances are you to allow oil to drain on the ground as it will eventually contaminate our water supply and there is \$500 fine for doing that.

Now that you've got your used motor oil and your oil filter, where do you take it? Fortunately, many **auto parts** stores **Jiffy Lupe, O'Reilly, auto Zone** and some service stations will accept used motor oil and oil filters for recycling, as well as transmission oil and gear oil and brake fluid.

Used motor oil can't be recycled if it's mixed with other liquids like antifreeze or brake fluid, **so keep your vehicle's other liquids separated.**

### **How to Safely Dispose of your old tires**

When you replace your existing tires, all tire centers will keep your tires and charge you a disposal fee. Do that. Do not keep the used tires unless you can find a specific use for the tires. Do not throw your tires away anywhere as there is a \$500 fine for doing so.

***Used tires can be taken to: Buckman Recycling which is at 2600 Buckman Road in Santa Fe. They charge \$2.00 per tire (up to 10) for passenger tires and \$6 per tire for larger commercial tires.***

### **How to Safely Dispose of old Antifreeze**

Drain the fluid into a clean container and take to the Jacona Transfer Station as they accept antifreeze (limited quantity). Remember that antifreeze is a pollutant and will kill pets and small animals as they love the small and taste. Do NOT pour the antifreeze down your drains!

## Notes

It truly is best for you to allow mechanics to do your fluid replacements so you don't have disposal problems. They will take care of getting rid of your car's fluids (Oil, transmission fluid, gear oil, brake fluid, power steering fluid, antifreeze).

Jiffy Lube sells 3 pack coupons that reduce the cost for oil changes.

If you must do your own maintenance, make sure you have 2 separate containers for each fluid type. You should use a two step process. Get a large open container to catch the oil, transmission fluid or antifreeze, then pour that in to a closable container and take to a place that accepts such fluids. You will need 2 separate containers (one for drain and one for transfer) **for each type of fluid** as you should not mix your fluids as this contaminates the fluids.

These closable containers can be bought at auto stores, and you can get open plastic/aluminum containers at other stores (Dollar General, Family Dollar, WalMart). One container needs to be closable so that they won't spill in your car when you take them to be disposed of. And make sure you get good size containers. Oil containers need to hold about 6-8 quarts of oil. Transmission container about 10 quarts. Brake fluid about 2 quarts. Antifreeze 1-2 gallons.

Dispose of your fluids as soon as possible. Don't store them! They can tip and spill on the ground, or pets or small animals can ingest the fluids or fall into the fluids and die such as birds mistaking the fluid as water (seen it).

Worse comes to worse, come to the Transfer Station and borrow containers for you to do your oil change, transmission change, etc. But you must return the containers within 24 hours empty, **which means it will be your responsibility to take the fluids to a disposal site** (Jiffy Lupe, O'Reilly, or auto Zone). The transfer station will not do that for you.

Try to do you fluid changes on concrete so that if spilled, the cleanup would easy as opposed to the ground. Use a plastic tarp or cardboard if you are doing it on ground to contain spills.

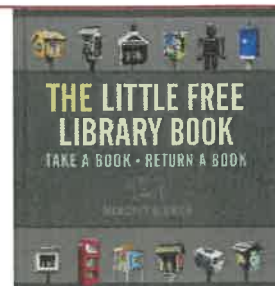

West Indian shipping company and was able to arrange a job for Alex's father. To take this new position, James Hamilton moved his family to the bustling seaport town of Christiansted on the larger island of St. Croix, a town consisting of warehouses, stores, shipping posts, a church, and a fort that was used as a prison.

After arriving in Christiansted, Alex learned that his mother had a secret: She was married to another man. On Nevis, his mother had been able to pass moved because it was on St. Croix that Rachel had been married to someone else — and imprisoned.

Rachel was a girl of sixteen when she married John Michael Lavien, who was about thirty at the time. She didn't want to marry him but gave in to the urging of her mother, who mistakenly believed that Lavien was a man of wealth. In fact, Lavien was the opposite; he peddled dry goods, hoping to advance himself into the planter class. He wanted to marry Rachel because at that time, her family still owned the small plantation.

Rachel came to hate her husband, who Alex later described as crude and overbearing. A year after they were married, they had a child, Peter. After a bitter falling-out, Lavien publicly accused Rachel of having affairs with other men and had her imprisoned for several months, thinking that imprisonment would turn her into the meek and obedient wife he wanted. When she was released from prison, instead of returning to her husband, she fled to Nevis, where she met Alex's father. By the time she returned to St. Croix with James Hamilton and their two sons, her eldest child, Peter, who was then about nineteen years old, had gone to live in South Carolina. Lavien had moved to the other side of the island, from Christiansted to Frederiksted.

About a year after Alex and his family moved to St. Croix, Alex's father scored his first business success: He managed to collect a large debt owed to the company he worked for. Shortly afterward, he deserted his family forever, leaving Rachel to care for their two boys.

He went to the nearby island of St. Kitts. Soon the money he'd earned was gone. He drifted farther south, where he lived out the rest of his life in

#### About:

The Native American Advised Fund, at the Santa Fe Community Foundation, was established in 1993 with a gift from the late Allan Houser (*Chiricahua Fort Sill Apache*), a humanitarian and one of the world's great artists. Grants are made from the fund based on the recommendations of an advisory committee. All members of the advisory committee are drawn from the local Native American communities.

The purpose of the Native American Advised Fund is to enhance Native lifeways now and for future generations in New Mexico by promoting a spirit of sharing and supporting community initiatives. The Fund supports efforts that emphasize the commitment to Native core values: community, language, culture, and environment. Since 1997, the Native American Advised Fund has granted over \$500,000 to over 60 different tribes, schools, and organizations. The Fund will operate in perpetuity, benefiting this and future generations.

#### Requirements:

- The design should be colorful and graphically appealing in its representation of the Native American Advised Fund.
- Design should relate to Native people, New Mexico, or its land and/or surroundings.
- Design should be complementary to the Santa Fe Community Foundation's logo in keeping with its branding. It is the intent to leave as much creative freedom to the applicants, but we recommend that you consult the Santa Fe Community Foundation's website for further review. Click for [horizontal](#) and [vertical](#) logos.
- Applicants should be Native Americans living in New Mexico.
- Readability in both forms and fonts are among the primary characteristics of the logo; it should include the name, Native American Advised Fund.
- All designs must be original, with a maximum of four colors.
- Applicants may send more than one logo design.
- The logo should be provided in vector format (.eps, .ai, with transparent background) and in photo format (.png with transparent background and jpeg); it must have resolution options that overlay it for a video up to 300dpi; and it must be possible to apply either on light or dark backgrounds or with the same file or with two files, one positive and one negative. Color profile in RGB and CMYK (for color printing).
- The selected logo design will become the exclusive property of the Santa Fe Community Foundation, with all copyright and use of the design held by the Foundation.

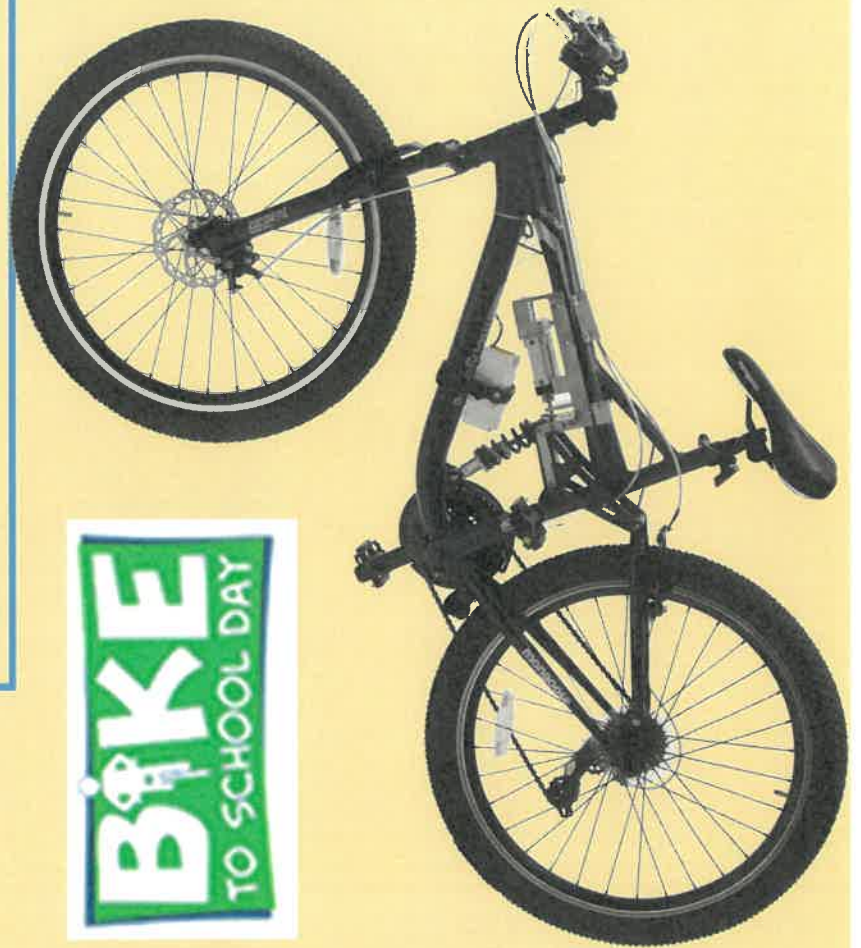
