Abandoned Vehicle Act

The Abandoned Vehicle Act of 2018 was approved by the Tribal Council on July 24, 2018. The purpose of this Act is to "promote a safe, clean and healthy environment by removing abandoned vehicles from Pueblo lands." The definition of an "Abandoned Vehicle" means any Vehicle that is inoperable, or has not been driven for more than sixty (60) days and is located on any property within Pueblo lands. There are currently 73 identified homes with abandoned vehicles within the Pueblo lands. It is in the best interest of the Pueblo's environment that this Act be enforced going forward.

<u>3 Branch Session</u>

The Executive, Legislative and Judicial branches met on July 22, 2021 to discuss and work through issues and topics to ensure a positive and productive government for the People and to update the branches on any work over the past year and to address any needs or concerns that each branch may have.

COVID Financial Assistance

7/1/2021

In late June 2021 the Tribal Council met and updated the Pueblo's financial assistance program.

As of July 2021, the financial assistance program will be updated as detailed below:

Internet Assistance will continue unchanged and will now expire on June 30, 2022.

Financial Assistance will continue in a smaller capacity and will be evaluated in September 2021 by the Council to determine whether it will continue.

- Total financial assistance allowed to each household will be a maximum of \$500 per month
- Only eligible household expenses for assistance will be electricity, heating and mortgage
- Assistance checks will be made directly to the utility provider and/or housing authority—not to the household
- Internet bills will be reimbursed separately with the internet assistance reimbursement request
- Required certifications for each month will still be documented by weekly unemployment certifications or, in the case of self employed, a signed certification asserting continued loss of business income.

What is ICWA?



"ICWA" stands for the Indian Child Welfare Act, a federal law passed in 1978. ICWA was passed in response to the alarmingly high number of Indian children being removed from their homes by both public and private agencies. The intent of Congress under ICWA was to "protect the best interests of Indian children and promote the stability and security of Indian tribes and families" (25 U.S.C. 1902). ICWA sets federal requirements that apply to state child custody proceedings involving an Indian child who is a member of or eligible for membership in a federally recognized tribe.

Kill flies instantly

To make your own homemade fly killer spray take an empty spray bottle. And add 7 – 10 drops of dish soap and add 2 cups of warm water. Now close the lid of the spray bottle, shake the solution, and your homemade fly killer spray is ready. Spray it directly on the flies and watch them perishing instantly.

What will keep flies away?

Lavender, eucalyptus, peppermint, and lemongrass essential oils. Not only will spraying these oils around the house create a beautiful aroma but they will also deter those pesky flies too.

Lemons and cloves

Common house flies also carry several types of bacteria that could make you or loved ones violently ill. Using lemons and cloves to keep this pest away is an easy and fast remedy, as flies can't stand the smell of either. Use two lemons and cut them into halves.

Penny in a bag

The penny in a plastic bag of water works great to keep flies away. Try hanging it on your door, like a wreath, to keep flies out of the house.

How do you make homemade fly spray?

Oil Blend Homemade Fly Spray Recipe

- 1. 4 cups apple cider vinegar
- 2. 2 tablespoons of olive, canola, or mineral oil
- 3. 1 tablespoon dish soap
- 4. 20 drops rosemary oil
- 5. 20 drops basil oil
- 6. 20 drops peppermint oil

By recognizing the needs of Native Americans we continue working towards equitable solutions for the issues our New Mexico communities face.



2021 KEY LEGISLATIVE VICTORIES FOR INDIAN COUNTRY

HB6 STATE EQUALIZATION GUARANTEE DISTRIBUTIONS

Properly directs millions in federal Impact Aid dollars to schools serving Native American communities and other federally underserved students. Recurring funds will be apportioned from the general fund to ensure all districts continue to receive funds.

SB 84 COMMUNITY SOLAR ACT

Provides for the development and operation of community solar facilities by providing credit value for the electricity generated. This will expand and develop native community solar programs and access to this renewable energy source for businesses and individuals.

HB 231 NATIVE AMERICAN POLLING PLACE PROTECTION

Guarantees that polling locations on Indian nation, tribal or pueblo lands shall not be eliminated or consolidated with other polling locations without the written agreement of the Indian nation. tribe or pueblo on which the polling place is located.

SB 112 SUSTAINABLE ECONOMY TASK FORCE

Stratter Barris

The sustainable economy task force shall develop a strategic plan in fiscal year 2022 to transition the state economy away from reliance on natural resource extraction. The advisory council shall include eight representatives of tribal governments or entities.

Native Americans face a myriad of obstacles when it comes to voting, including the lack of a traditional mailing address, difficulty meeting identification requirements, unequal access to registration, and even direct voter suppression," said Rep. Johnson. "House Bill 231 eliminates one major barrier to entry by ensuring that Native residents in New Mexico have guaranteed access to vote at convenient and accessible locations." -Rep. SB 304 VOTING DISTRICT **GEOGRAPHIC DATA**

The secretary of state shall collect and make publicly available the geographic information system data for each voting district. To the extent possible districts shall be drawn to preserve boundaries of Indian nations, tribes, and pueblos.

Following the historic appointment of Secretary Deb Haaland to lead the Department of the Interior, New Mexico is holding a special election to fill the vacancy in New Mexico's First Congressional District on Tuesday June 1, 2021.

Her upbringing inspired her career in community development and sustainability, including working as a STEM educator and professional addressing land and water issues across the state; in the White House Office of Management and Budget and the U.S. Senate, where she worked on climate initiatives, tribal affairs, science policy, and the federal budget; and as a legislator, where she dedicated her work to hunger and homelessness, climate change, and water resilience.



In Congress, she will continue these efforts, working with President Biden to tackle poverty, protect our planet, remove disparities in healthcare, and develop an economy where New Mexicans thrive.

Melanie proudly supports tribal communities and looks forward to working in consultation with Tribal Nations at the federal level. She understands that Tribal Nations are inherently sovereign and the U.S. government has a solemn responsibility to recognize, uphold, and strengthen its relationship with our sovereign Tribal Nations.

In the state legislature she sponsored and cosponsored numerous bills aimed at addressing social injustices and improving the quality of life for tribal communities, such as:

- HB 278: Missing and Murder Indigenous Women, creating a task force to address the emergency of missing and murdered Indigenous women and relatives in the state.
- HB 651: Water Data Act, to improve water security in NM through better planning and management as coordinated with Tribal leaders.
- HB 10: Broadband Development Division, to expand broadband access in conjunction with at least three Tribal governments on a statewide advisory group to help design, develop, and implement broadband services.

SECRETARY DEB HAALAND

Former Representative Deb Haaland made history on March 18, 2021 when she was sworn in as the first Native American Secretary of the Interior, and became the first Native American to hold a Cabinet-level position in the United States.

Representative Haaland was elected to the House of Representatives in 2018. During her time in Congress, Representative Haaland focused on advancing policies that directly benefit New Mexico's first Congressional district, while staying true to her strong progressive values.

As a Congresswoman, she held nearly 200 events to connect directly with her constituents and secured significant benefits for New Mexicans in legislative packages like the FY21 Agriculture appropriations bill and the American Rescue Plan.

As Chair of the Subcommittee on National Parks, Forests and Public Lands, Representative Haaland shepherded the Great American Outdoors Act and a bipartisan Public Lands Package through her subcommittee to the House Floor. She is known for her ability to work across the aisle to pass common sense measures that directly benefit communities in New Mexico and across America.
