**Rental Fee:** Rental fees will be charged according to the rates above. The rental fee is due and payable upon approval. Cash or checks made payable to the Pueblo de San Ildefonso are acceptable forms of payment.

**Deposit:** A Damage Deposit (also called a cleaning deposit) is required before facilities are used and is eligible for refund once the Pueblos Parks and Wildlife Department inspects the field after the event occurs.

#### General Terms and Conditions

- 1.a Renter agrees that the information provided above is correct, including but not limited to, rental hours, event type, number of guests, etc.
- 1.b Renter agrees to the above stated damage deposit and refund procedures.
- 1.c Renter agrees to be solely and completely responsible for the condition of the reserved area and to leave it in neat and clean condition, without damage. Renter agrees to reimburse the Pueblo de San Ildefonso for all damages.
- 1.d Renter is informed that there are no toilet facilities and will make their own arrangements for such if needed.
- 1.e **Alcohol Prohibited.** The use, consumption, sale and possession of alcohol are prohibited on all Facilities and property.
- 1.f In consideration for Pueblo de San Ildefonso granting the privilege to use certain facilities, the Renter agrees to defend, indemnify and hold harmless the Pueblo de San Ildefonso, its officers, officials, employees and agents, from and against all liability, claims, suits, judgments, and expenses, including court costs and attorney fees, on account of any injury, loss or damage, arising from or in any manner connected with this Rental Agreement, or if such injury, loss or damage is caused in whole or in part, or is claimed to be caused in whole or in part, by the acts, errors, or omissions of the Renter or the Renter’s family, employees, service personnel, guest, or agents with respect to the use or occupancy of the Facility, its amenities, parking lots, and the surrounding area.
- 1.g Renter understands and agrees that the use of the facility is subject to notice that the facility is not available for certain dates. The pueblo will provide notice of non-availability to the renter.
